Due to all the previous Parish Councillor's resigning, a new Parish Council (PC) had to be formed on a temporary basis which had to be approved by North Yorkshire Council. All the Parish Councillors here volunteered to resurrect the PC rather than see the Parish been ran by another villages committee appointed by North Yorkshire Council.

A meeting was then held on the 8<sup>th</sup> January to form the new PC.

Due to there being no handover from the previous Councillors everything has been channelled through Jenny the PC Clerk, to whom we are most grateful for all her help and advice.

During the short time the PC has been formed we have started to pick up some of the actions that had been agreed by the previous PC as well as making a to do list of items that require addressing.

The village community web site which was established by Chris Dickenson has now had a makeover and all PC information can be found under the PC tab.

Within the website under updates, you will be able to find copies of the todo lists with actions completed, actions in progress and actions that have not been started.

# **Financial Information**

Financially the PC is not in the healthiest place and careful budgeting is required over the next few years,

The Parish Precept was £4284 2023/2024

The PC requested an increase of 5% to £4499

As most of you will see the council tax bill states a rise of 9%, this was queried with the North Yorkshire Council, the reason for the discrepancy falls back to the Council tax base rate dropping from £218.54 to £210.77 approximately 4%. The base rate changes each year commonly due to changes to the number, or council tax banding of properties or through variations in the level of discounts applied which reduce the taxable base (e.g. single person discount)

### <u>Money in the Bank</u>

The PC run two bank accounts, NAT WEST is the PC's current account where monies for maintaining the parish are deposited and paid out of, e.g. precept, encroachment fees etc incoming, with grass cutting, insurance etc outgoing.

The CO-OP account is ring fenced for maintaining, repairs and just recently inspecting the play park. The money in the CO-OP cannot be used for any other purpose as the money was raised by fund raising, donations and grants specifically for the renewal of the play park.
